| <ol style="list-style-type: none"> <li>1) School Principals are authorized after October 1 of each school year to assign empty seats on school bus vehicles to ineligible students on buses serving their schools.</li> <li>2) Where routes have been established and there are empty seats available on a bus, students may be provided transportation services as approved by the School Principal, in conjunction with the Ottawa Student Transportation Authority (OSTA), even though their distance from school is within walking distance.</li> <li>3) The Ottawa Student Transportation Authority reserves the right to withdraw such approval at anytime based on changing load count information and route efficiency requirements.</li> <li>4) Approval of access to empty seats shall not constitute a precedent nor establish a right to transportation.</li> <li>5) School staff will verify that the information on each application is complete and reflects the information in their student database.</li> </ol> | <ol style="list-style-type: none"> <li>6) School staff will review applications and grant approval, where empty seats are available and bus stops exist. Bus stops will not be added to bus routes for students approved from service under the empty seat/space availability provision.</li> <li>7) School staff will send notification of approval to OSTA and the school bus driver through the TRACS system, prior to placing the student on the school bus vehicle.</li> <li>8) Application for and approval of service shall be for the current school year only.</li> <li>9) The decision of the School Principal with respect to the assignment of empty seats is final, except where the OSTA determines that vehicle loads have been exceeded, or where operational efficiencies are possible.</li> <li>10) Where routes are combined and students from more than one member Board are riding the vehicle at the same time, empty seat applications will be authorized through OSTA only.</li> </ol> |
